ᅗ Public Policy

Only hibernating bears will be unaware of the health care bills staggering their way through the House and Senate. What the final bill will look like is anybody's guess but these are the parts AAUW would like to see retained:

- End the practice of gender rating;
- Require coverage of women's reproductive health services;
- Ensure access to and coverage of access to preventative services and care.

A very useful resource with detailed analyses of all the key aspects of coverage can be found online at the Kaiser Family Foundation website, http://healthreform.kff.org/. It is updated frequently and contains helpful comparisons of the Senate and House bills. Current topics explored in depth include:

- Implications for women's access to coverage and care:
- Medicare buy-in option for older uninsured adults:
- Immigrants' health coverage and health reform: key questions and answers.

Now that the Health Care Reform bill has passed in the Senate, a joint conference committee will work to integrate the Senate and House bills into a single bill for President Obama to sign.

Current law, reinforced in both bills, already dictates that federal taxpayer dollars cannot be used to pay for abortion. However, as you know, the Stupak amendment would eliminate private insurance coverage for abortion services under health plans offered in a government-run exchange system, effectively instituting a domestic gag rule. If language similar to the Stupak amendment is included in the final health care reform bill, millions of women, including those in private plans who paid premiums with their own money, would lose the coverage they currently have. We need to continue to fight to ensure that measures like the Stupak amendment, and any other attempts to weaken women's access to complete reproductive health care coverage that go beyond current law, stay out of the bill that ultimately reaches the president's desk.

As AAUW members, we should continuously monitor activity on this legislation, contacting our representatives if we see the bill getting out of hand, AAUW-wise.

Please contact Senators Dianne Feinstein and Barbara Boxer, thanking them for their vote on the Nelson Amendment (that allowed the Senate bill to pass at all), and asking them to continue to work for inclusion of the principles that AAUW supports in the final Health Care Reform Bill.

Our Congressman Wally Herger continues to voice his opposition to any health care bill at all, while as a member of Congress he enjoys the best health care the country has to offer.
