■ Directions To Vista Village

From Paradise: Drive down Skyway to the lower end of Paradise (past Neale Rd. and the split). Turn left at the Vista Village sign (Vista Village Drive, just past the first Russell Ave. which is on the right). Take the **first right** inside the development, drive down to the clubhouse/pool area (visible) on the right. **Turn right** (Granada Vista Drive) to parking. (You'll see the pool).

OR, if you miss the first entrance to VV, drive to the next street – Skyway Crossroads - and turn left (this is the road that connects Up-Skyway to Down-Skyway at the Entering Paradise sign.) Turn left into Vista Village; the clubhouse/pool are on your left. Lots of parking. Stairs (14, with handrails) down to the clubhouse are in the middle.

From Chico: Drive up Skyway to Skyway Crossroads (by the Entering Paradise sign); turn left, then right into Vista Village. The clubhouse/pool are on your left. Lots of parking.

Avoiding steps/handicapped parking: If you want to avoid the 14 steps from the parking area to the clubhouse, go to the end of the street (past the parking spaces), make a left down to the handicapped parking by the clubhouse. Questions: Carol Holzgrafe, carol@holzgrafe.com or 873-6906

Supreme Court Hears Follow-up to Hobby Lobby

Last month, the U.S. Supreme Court heard arguments in *Zubik v. Burwell*, a set of consolidated cases that pose a looming threat to women's access to reproductive health care. In 2014's disappointing *Burwell v. Hobby Lobby* decision, the Supreme Court ruled that **some corporations** can't be required to cover contraception through their employee health insurance plans. Following on the heels of *Hobby Lobby*, a number of religiously affiliated nonprofit organizations filed suit to limit contraceptive coverage even more. Although the Affordable Care Act includes an **AAUW-supported** accommodation for religiously affiliated nonprofits that object to contraceptive care on religious grounds, a small number of religious nonprofits claim that the accommodation does not go far enough. Those nonprofits are the plaintiffs in *Zubik*. Oral arguments suggested that the court might seek some alternative method for ensuring employee access to health care. Stay tuned to *LAF Express* for more information.


■ Dues are Due
